Part B. CV SUMMARY (max. 5000 characters, including spaces)

I have a world reputation for developing innovative research in the field of domestic abuse, gang research, crime prevention, and data science applications in policing. Key contributions include: *Gender and violence*.

- Led the 1st national survey on violence against women in Spain.
- Using spatial econometric models and GIS, developed ground-breaking research on the community risk factors for violence against women in the US, that informed both the National Science Foundation and the National Consortium on Violence Research agenda.
- Contributed to 1st national study of Homicide in the UK, with a focus on analysis of intimate partner homicide.
- Directed largest study of police risk assessment tools for domestic abuse using machine learning tools.

Gangs.

- Co-directed 1st large ethnographic study of youth gangs in UK.
- Contributed to the development by the Home Office (and led subsequent statistical analysis) of the first national (longitudinal) survey of youth gangs in England and Wales.
- Participated in the direction of the Eurogang Network for 11 years largest consortium of gang researchers in Europe.
- Analysed data from a large mixed method study of gangs in Central America.
- Contributed to research projects to estimate prevalence and nature of youth gangs in Madrid.

Crime prevention.

- Published research monograph widely circulated and read in Spain and Latin America.
- Led analysis of 1st randomised control trial of policing elder abuse with funding from the US Department of Justice.
- Co-PI in large ESRC study focused on the regulation and prevention of food fraud.

More recent work is exploring the geography and spatiotemporal distribution of crime and the risk assessment of gender violence in Spain, the implementation of VIOGEN protocols by Spanish police, the topic of police reform, and the governance of crime policy at the local level in mid size cities (all funded by different agencies). I have a history of successful research funding as Principal Investigator (£1,241,290 since 2009) and publication, as one of the most cited Spanish criminologists. I have supervised 16 PhD students to completion.

I also have demonstrated strong leadership credentials at the University of Manchester, as Head of the Criminology Department (under my lead our UG degree was ranked as best in the UK), and internationally, as elected President of the Spanish Society of Criminology from 2016 to 2020. I am the lead of the Working Group on Policing Research of the Spanish Society of Criminology. My research has a history of collaboration with public agencies to develop evidence-base practice and policy (Home Office, College of Policing, Greater Manchester Police, Open Society Foundation, NYC Department of Public Health, United Nations, Manchester City Council, Swedish Agency for Foreign Aid, etc.) and political actors, for whom I have coordinated policy manifestos. I also have a commitment to pedagogical innovation, particularly in the teaching of quantitative skills to social science students (I am a certified data carpentry instructor) and data science skills to police analysts – all of which has resulted

in the publication of 2 textbooks (Springer and CRC Press) focusing on stats using R and crime mapping using R.

I held ongoing honorary appointments as an External Collaborator of the Institut d'Estudis Regionals i Metropolitans de Barcelona and as an Honorary Research Professor at the University of Manchester (Department of Criminology, School of Social Sciences). I served or have served in the editorial boards of The British Journal of Criminology, Psychosocial Intervention, International Criminal Justice Review, Revista Española de Investigación Criminológica, and Pedagogia i Treball Social: Revista de Ciénces Socials Aplicades, and serve as an ambassador of CrimRxiv. I have recently been appointed as ambassador of the Oficina Española de Integridad en Investigación.
